Re: Losses resulting from delinquent California state income tax returns

Dr. Viders:

This is in response to your call asking for a summary of the additional cost that were incurred due to the failure of Dr. Dan's outside accountants to timely prepare and file California state income tax returns for years ended 12/31/2017, 12/31/2018, 12/31/2019.

1. Additional Tax Liability - The periods in question are calendar 2017, 2018 and 2019. Had the returns been timely filed, there would have been a liability based upon the California minimum franchise/income tax liability of \$800 for the first two years, and based on the information available to us, nothing for the third. Thus, the total liability should have been \$1,600.00. Since returns were not filed on a timely basis, California made a projection of the company's income issued a Notice of Assessment indicating a liability totaling \$43,761.63 (see attached). We assisted in the preparation of delinquent tax returns for the three periods in question which resulted in the following assessments:

We anticipate that we will be able to but are still working with the California Franchise Tax Board in order to eliminate the assessment for 2019 in its entirety. It is our understanding that some additional charges for penalties and interest were incurred in the process of trying to get these reduced assessments for 2017 and 2018 paid off. You should have records of these added costs. Obviously, the penalties and interest would not have been occurred had these state income tax returns been timely prepared as the accountants indicated they would do.

- 2. **Professional Fees** Attached is a summary of our billing records concerning professional fees incurred in attempting to reduce the liabilities. The current total ignoring potential additional fees and expenses in eliminating the assessment for 2019 is \$4,456. Again, this is an additional cost that would have been incurred but for the fact that the accountants failed to timely prepare tax returns for the periods in questions.
- 3. Lost Accounting Records- At this juncture, we are not in the position to offer any advice as to what liability, if any, has been incurred as a result of the accountant's loss of your financial records. One alternative would be to project the cost associated with reconstructing these records (presumably a substantial amount). A second alternative would be to estimate the additional cost that you incurred in attempting to deal with this error (i.e., additional time incurred by you and other employees of the company) and leave the issue open in the hope that the loss of records for these prior years will not give rise to any material issues. Again, we have no basis for determining what additional cost were incurred but we presumed that they were not insubstantial.
